## Plot Twist: Dr. Michael Nuccitelli IS The iPredator

**Update**: Analytics for this site show that Dr. Nuccitelli has read this article and disregarded it.

Dr. Michael Nuccitelli is a psychologist in Brooklyn, New York, who claims to be an anti-cyber stalking activist; he runs a website promoting a concept called iPredator, which purports to provide "expert analysis" of cyber stalking and cyber stalking concepts.

Dr. Nuccitelli publicly endorses the movie Social Media Monster, a veiled political propaganda film that attempts to erase my vast, national environmental and anti-corruption activism work, my film career, and journalism, replacing it with the ludicrous allegation that I'm an "internet troll" who is not an activist, filmmaker, or journalist. Cracking the code of the film isn't hard when one reads a comment posted on the fan page from St. Joseph City Councilman Brian Myers, "This film is a gift to police and elected officials everywhere."

It should be nothing but obvious, to even the casual layperson, that the director of the film is a pathological and habitual liar, cyber bully, and stalker, but Nuccitelli has publicly endorsed the film, and made atrociously deranged allegations against me, while using no due diligence, whatsoever. The doctor has even gone to the lengths of enjoining with the production by assisting the director with securing podcast appearances which have been used to disseminate funneled disinformation used to smear my name and reputation, discredit my work for ToxicWasteSites.org, and launch personal attacks.

What disturbs me the most about Dr. Nuccitelli is, based on the director's public statements, the doctor has acknowledged the film's infliction of extreme emotional distress upon me, and Nuccitelli's claims that I'm going to "snap and commit a murder." Nuccitelli steadfastly continues to support, promote and back the film, even in the presence of glaring and confounding pathological lies dished out by Peter John Ross, the director of the film.

On the podcast *Causing the Effect*, Ross made claims that I don't support my children, even though Summit County, Ohio public records reflect that I paid child support for my now 26 year old son, for eighteen years. On *What Matter With Mindy and Mikaela*, on radio 610 Columbus, Ross claimed, "He has no job so there's nothing to take from him," as only 24 hours later, the director ran public campaigns encouraging his followers to report my very successful handyman side-business to California and Nevada Attorney General's offices. As the director appears in media — the lies are compounding and becoming more and more detached from reality — Nuccitelli provides positive reinforcement to Ross.

All I've asked from Dr. Nuccitelli is that he speak to me, look at the evidence against Ross and consider the irony that a large percentage of his writings on cyber stalking actually describe the tactics being used by the director, not me. Nucitelli even aids Ross in circulating the ridiculous notion that I believe I am a victim of a concept called *gangstalking*, portraying me as a schizophrenic; I've never experienced delusions, hallucinations, heard voices, or suffered from paranoia. Ernest Halcon, a producer on the film and a retired FBI agent, has repeatedly accused me of believing that I'm a victim of a "deep state plot" when I've never stated anything of the sort. I've constantly reminded people that I do not believe I'm being harassed by the government, in spite of the fact that I expose fed corruption, via ToxicWasteSites.org.

It's patently disturbing to me that a psychologist would target me in this manner, fully aware he's triggering extreme emotional distress, apparently even making conscious efforts to wound me to the point that I snap and commit the very "murder" he claims I'm going to commit. The plot twist in this story, which shouldn't surprise anyone, is that Dr. Nuccitelli is the very iPredator that he says he's on a mission to stop. His vast writings on cyber stalking are nothing more than a manifesto describing his own behavior, or what would be called *psychological projection*.

I liken the doctor to a Nazi scientist who is engaged in a pure evil, sociopathic pattern of unconscionable and astoundingly vile actions; that he's shown no empathy or sympathy for me has made me realize how truly dangerous this man is to anyone who becomes involved with him. His monomaniacal obsession with cyber stalking has turned him into the very predator he claims to be fighting, turning myself, my .org, my causes, and the millions of people I'm fighting for, into collateral damage victims of his twisted agenda.

Nuccitelli, who runs social media, does podcast appearances, appears on television, and gives speeches even has the utter nerve to accuse me of having a relentless desire to be famous while ignoring the fact that I'm doing virtually nothing to promote my own name, career, or activism work. For a reason that cannot be ascertained, it's completely OK for the good doctor to shamelessly self promote but if even make one single public comment I'm "obsessed with fame" and will "kill to obtain it."

I can wholly assure the reader that the moment he reads this, he'll proclaim himself to be a victim, acting out the behavior of a narcissist he describes on his own website. Much like Ross, he's incapable of seeing himself for what he truly is, while I assert that both of them are driving me crazy to the point that I don't even want to be alive. It seems both of them are on a Hail Mary mission to bully me until I take my own life. Considering that I've publicly spoken about repeated suicide attempts in my 20's, and the resulting Post Traumatic Stress Disorder, his fixation on me has its own self-implied sinister intent.

When I communicated to Dr. Nuccitelli that he is placing my life in danger, he only became worse. When I attempted to report his conduct to the New York State agency which accredits him, rather than self reflect, he doubled down on his claim that even though he's the one publicly targeting me that he's the victim, when he's clearly not. Glaringly, I'd never heard of him until he began targeting me.

I want to heavily reinforce that I've never met Nuccutelli. I've never spoken with him directly. He's conducted no medical assessment of my case. He's never viewed my medical records. His actions towards me are nothing less than a malicious form medical malpractice that demands the revocation of his state licensure. Any patient that trusts their mental health to Dr. Michael Nuccitelli is coldly viewed as lab rats to his emotionless reptilian mind.

I'd like to remind anyone who considers Dr. Nuccitelli's opinion of me that it's illegal for a licensed professional to diagnose or treat a patient or party without an appropriate evaluation, that Nuccitelli is treading into criminal behavior by continually, publicly diagnosing me by proxy, through Peter John Ross, and it's putting me at risk of suicide.

The bottom line here is that the continued and ongoing lies of Peter John Ross are far too glaring and obvious for Dr. Nuccitelli to be unaware of what he's involved in. To suggest an expert on cyber predators is unaware of his own actions and doesn't know what he's doing would be for Nuccutelli to admit he was foolish enough to be duped by an iPredator. Two age old maxims come to mind: Never attribute to conspiracy what can easily be attributed to idiocy *and* its easier to fool a person than to convince them they've been fooled. In the case of Dr. Nuccitelli, and the clear notifications of his negligent
